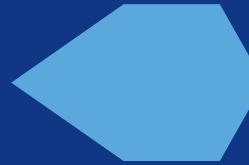
**Department

Undoubtedly, in the realm of theoretical discussions, the main and fundamental challenge of any society, especially a religious community, is how to encounter philosophical and religious issues. The strength of a community is always dependent on its intellectual and theological foundations, and its destruction or collapse arises from the weakness of these foundations. Hence, intellectual foundations of societies have always been attacked by their enemies and deniers in various ways, often in the form of philosophical and theological skepticisms which have, of course, already been doubled in our society due to the formation of a religion-based government, and have taken political and cultural directions. Scholars, especially Muslim theologians and philosophers, have considered their main scientific and theoretical task to consist in a correct interpretation and explication of the intellectual foundations of society as well as a defense of their status against skepticisms. And this is a task that has become more difficult for religious and seminary scholars, especially, if we consider the very important point that the objections and skepticisms which threaten the foundations of faith and religious beliefs at the present era and raise concerns for the society, particularly young people, are planned in completely different forms from and with very distinct methods compared to the past. Thus, confronting and responding to such a situation requires arranging and explicating the precious heritage of the past in a new form and obtaining new abilities in response to skepticisms and criticizing new intellectual issues. RCIPT affiliated to ISCA was established in 1994 in order to explain and introduce the theoretical doctrines of Islam with a rational-transmitted approach, recognizing and reconstructing the philosophical and theological heritage and responding to intellectual skepticisms. In recent years, in addition to conducting research on intellectual issues of the day, the rich heritage of Muslim thinkers and the deployment of modern research methods in the field of Islamic sciences to foster fundamental studies, this research center has implemented several great research projects such as Theological Teachings of the Twelver Shi'a Theologians. Also, important intellectual and practical areas such as "moral philosophy" and "philosophical psychology" as well as comparative studies in the field of "religion and reason" and "religion and linguistic knowledge", are among the prominent projects of this research center. Investigation and enhancement of Islamic philosophy and its relationship to social and political needs, as well as a modernization of Shi'a theology in order to be more active in facing up to rival thoughts, are some of the most important projects in current and future plans.

Objectives, Policies and Duties

Objectives

1. Explicating and reforming the foundations and theoretical frameworks of Islamic philosophy and theology in order to develop and enhance them, and also to meet individual and social needs.



2. Recognition and systematic explanation of theoretical doctrines of Islam.
3. Rational defense of Islamic doctrines and response to philosophical and theological doubts.
4. Innovations in presenting Islamic doctrines and making them comprehensible to audiences of all types.

Policies

1. A scholarly and logical look at intellectual issues and a concern for scientific and rational investigations, and an implementation of efficient research.
2. Adherence to genuine Islamic principles and taking research pathologies into account, as well as avoiding eclecticism, intellectual dogmatism and intellectual superficiality.
3. Knowing the audience and matching contents of the research with the features and needs of the audience.
4. Considering skepticisms and new philosophical and theological issues.
5. An attempt to investigate the religion and religiosity requirements of contemporary human being.
6. An active, rather than passive, approach to philosophical and theological issues and

theorization.

7. Trying to communicate and interact with scholars and thinkers and draw upon their capacity and achievements in the field of Islamic philosophy and theology so as to carry out the tasks and research activities.
8. Using up-to-date and effective literature to present research achievements.
9. an attempt towards intellectual effectiveness and improving spiritual beliefs of the audience
10. Turning research fields pertaining to Islamic philosophy and theology into specialized ones
11. Determining research priorities according to necessities and needs
12. Deploying achievements of human sciences and knowledge along with a critical attitude towards its shortcomings and its inconsistencies with Islamic thought
13. Prioritizing group activities and collective thinking on philosophical and theological studies
14. Observing scientific criteria and standards and applying new methods and tools in philosophical and theological research.

Duties

 5. Study, research and implementation of research projects on the doctrinal system of Islam
 6. Identifying philosophical and theological skepticism and providing appropriate responses
 7. Identifying various audiences and expressing Islamic teachings according to their needs.
 8. Creating specialized groups in order to carry out research plans and activities
 9. Providing a context for dialogues among Muslim scholars and holding conferences with philosophical and theological topics
 10. Identifying and attracting researchers and supporting the scholars of the Islamic Seminary in the field of philosophy and theology with the aim of providing a context for their growth and promotion.
 11. Providing research resources and contexts to facilitate research in the field of Islamic philosophy and theology
 12. Providing a context for the growth and enhancement of knowledge and ability of researchers through courses and workshops, scientific meetings and discussions, creating opportunities for study, etc.
 13. Informing Islamic seminaries on the novel issues and challenges of the Islamic society in the field of philosophy and theology.
 14. Communication and cooperation with organizations, institutions, authorities, cultural elites, institutes and scientific, research and executive centers in order to advance the goals of the research center.
 15. Building active and constructive relationship with other research centers and divisions of ISCA with the aim of establishing coordination, implementing joint plans and preventing repetitive work.



**An Introduction to
Research Council**





The research council of RCIPT has been established with the aim of promoting and advancing research projects of the research center, with the membership of thinkers and experts in the field of philosophy and Islamic theology. This council is the most important pillar for the planning, guidance and supervision of the research center, and all research projects will be finalized with its approval. In addition to conducting and overseeing research projects, the research council has an active participation in the approval and promotion of human resources of the research center, including faculty members, experts, researchers and scholars. Some of the council's duties are as follows:

1. Studying, reviewing and approving proposed plans of the research departments.
2. Studying, reviewing and approving brief and detailed projects
3. Checking faculty members' files for purposes of employment and promotion
4. Final approval and evaluation of works for publication
5. Approval of the condition of good execution of projects
6. Approval of scientific supervisors with the suggestion of the department chair, and so on.



**An Introduction
to Research
Departments and
their Activities**

At present, there are three active research departments in the research center:

1. **Department of Philosophy**
2. **Department of Islamic Theology**
3. **Department of Ethics**

The structure of research activities in each department is organized in three ways. The first part of the activity is typically done in the form of “monographs” (compilations and translations). The monographs consist in research individually conducted by scholars on independent subjects in accordance with the research center’s objectives and intellectual needs of the community. But in recent years, scientific and research activities have gone into long-term, group projects on basic issues and most of the activities have been carried out in the form of large-scale projects called “macro projects”. One of the priorities taken into account in the process of approving proposed projects is their alignment with these macro-projects. Macro-projects consist in research conducted by a group of scholars on a large-scale subject. Macro-projects have the capacity for various research activities, such as compilations, translations, collections of articles, scientific meetings, interviews, and so forth, and they are designed and implemented with the aim of fundamental and up-to-date research to enhance the existing cultural and intellectual heritage, reestablishing, designing new topics, discovering new domains and theorizing and advancing science with the discovery and actuation of the latent talents of researchers and improving the quality of their knowledge and creating scientific animation in the field of study and research. The third form of activity is “meetings and dialogues” held on some of the major topics, and their works are published in a series of dialogues.

Department of Philosophy

Philosophy has been prominent, since the very first centuries in the Islamic tradition, as one of the main components of human civilizations, and has been searching for truth through rational methods as a branch of knowledge, and in the Islamic world, it has been transformed into the form of Islamic philosophy according to the conditions of the Islamic society and now it is part of the intellectual-cultural tradition of Islamic civilization.

While acknowledging that the progress of any culture and civilization is impossible without an exploitation of its traditional heritage and the innovations and advancements of others, the Department of Philosophy in RCIPT works on two fields: Islamic philosophy and Western philosophy. By working on research projects in the field of Islamic philosophy, this department is seeking to irradiate and revive the intellectual heritage of Muslim philosophers. Investigation of dark corners and delineation of implications of different view, as well as expansion and refor-

mation of theories in Islamic philosophy are the most important goals of the Department of Philosophy. In the field of Western philosophy, this department draws upon its positive points and criticizes its negative points through centuries of studies conducted by Western philosophers. In addition, by comparing the Islamic and Western philosophical traditions, the Department of Philosophy can reveal the strengths and weaknesses of each, and broaden new horizons and then use them to advance the Islamic civilization.

Accordingly, the Department of Philosophy has designed and implemented large-scale projects in accordance with the aforementioned objectives.

Of these large-scale projects, we can refer to the macro-project “the capabilities of Islamic philosophy and its relation to social and political life.” The purpose of this project is to investigate the following question: “Does Islamic philosophy have to deal with abstract and theoretical thinking, or does it also have to deal with social and political domains? And does it basically have the ability and capability to enter such areas?”

Another large-scale project in the Department of Philosophy is “The Mind and Body Relationship “. Being implemented in two areas of “Islamic psychology” and “philosophy of mind”, this project tries to find an answer to questions by Muslim philosophers and present a new explanation of Islamic psychology, through investigating and introducing new theories of analytic philosophers on mind and formulating the Islamic psychology within Islamic philosophical systems by introducing issues brought up in the philosophy of mind.

The mind-body problem is one of the most fundamental topics in the field of philosophical study of the human nature, which has been discussed and investigated since early days by Muslim philosophers as well as philosophers in the West.

Since this fundamental issue has been dealt with in the teachings of divine religions and is closely related to the immortality of men and the quality of their resurrection, this religious and philosophical issue has been a concern of many thinkers. Today, in the West, new theories, including dualism, materialism and constitution, have been raised

as explanations of the mind-body relation, and a critical and comparative study of these theories with the theories of Muslim philosophers and theologians is a serious concern for the macro-project of “the mind-body relationship”. Thus, in March 2010, RCIPT organized an international conference on Religious Doctrines and the Mind-Body Problem which was highly welcomed by philosophers and thinkers inside and outside Iran, and the proceedings of papers presented in this conference were published in seven volumes. Due to common themes in the fields of Uşul (principles of Islamic jurisprudence) and philosophy of language, the macro-project of “Philosophy of Language and Uşul” has aimed at comparing these two issues and determining the strengths and weaknesses of each.

The programs of the Department of Philosophy are organized in the form of macro-projects, the plans approved by intellectual and cultural hubs in Islamic Propagation Office of Qom Seminary, compilation and translation of thematic monographs, as well as holding academic meetings and debates.



a) Macro-projects

1. Philosophy of Language and Uṣūl

Interactions and comparisons between traditions and different intellectual domains are very beneficial, especially, when new results

can be found to identify weaknesses and abilities of original intellectual traditions in the process of interacting and exchanging ideas. Undoubtedly, Uṣūl al-Fiqh (principles of Islamic Jurisprudence) is one of the richest heritages of the Shi'a seminaries. An im-

portant part of this science is the preparation and setting of general linguistic rules for inference of religious rulings through verbal reasoning. This section, which has been very productive and yet unknown, has not been commended so far.

Another point is that so far in the Western philosophical tradition, philosophers have conducted some research on language and its relation to reality and mind and have achieved some results. Today, these achievements are of interest to scholars of the humanities. Hence, investigating and comparing these two important intellectual domains from a philosophical point of view can lead to the interaction of these two domains, Uṣūl can benefit from linguistic sciences, and growth and enhancement of the production of science and theorizing. To accomplish such a goal, the macro-project of “philosophy of language and Uṣūl” has been devised and implemented, some of whose steps are as follows:

Preparing a collection of compiled and translated papers in two levels:

a) Introduction of the prospects, general overview and domain of linguistic issues

in Uṣūl and analytic philosophy

- b) Entering the major philosophical issues raised in these two areas, such as semantic problems, signification, intention, condition, speech acts, etc.
- Translation of the main and influential books of analytic philosophy for the correct promotion of this school and its localization.
 - Compilation of the book in the form of research projects on various philosophical problems related to the field of language through comparison and evaluation
 - Holding scientific meetings and discussions with a focus on analytic philosophy and Uṣūl
 - Asking questions and consulting the experts in order to benefit from various opinions

2. The macro-project of "The Mind-Body Relationship"

The nature of soul has always been of interest to philosophers because of its important

repercussions. But in recent years, the mind, its processes and its nature have attracted the attention of many philosophers in the West. Since the twentieth century is called the century of the philosophy of mind, attempts have been made to solve important issues of philosophy with attention to the mind-body problem. That is why the macro-project of "the mind-body relationship" has been established. Some of the scholarly-research works that are planned in this macro-project are as follows:

International Conference of Immortality of the Soul in Islam and Christianity

Department of Islamic Theology

Theology deals with arranging, organizing and explaining religious doctrines and elimination of doubts through rational and transmitted methods. In this regard, the Department of Islamic Theology in the research center has devised projects for studying of theological schools and the thoughts of various theologians, finding new answers and eliminating new skepticisms. While also paying special attention to the theological heritage of the past, the department attaches great importance to the philosophy of religion. At present, academic projects of the theology department are organized in the form of macro-projects “Theological Teachings of Imamiyya (the Twelver) Theologians” and “the Reason and Religion” and approved projects of the intellectual and cultural centers in Islamic Propagation Office of Qom Seminary, a compilation of thematic monographs on specific theological issues and currents, holding academic meetings and debates.

a) Macro-projects

1. The macro-project of “Theological Teachings of Imami Theologians”

One cannot study new theological issues and respond to today’s human questions without proper familiarity with theological principles and foundations and without considering the theological heritage of the past. The development of ideas and thoughts should be based on the past heritage in order not to get far away from its religious and ideological principles and suffer from intellectual and ideo-

logical deviation. To this end, the Department of Islamic Theology has a macro-project called “Theological Teachings of Imami Theologians” underway, as the first step in recognizing a comprehensive history of Imami theology. In this project, monographs on theological ideas of each prominent Imami theologians will be written, where they concern different periods of Imami theological life, in order to provide the requisite context for the compilation of a comprehensive history of Imami theology.

The first project is a reproduction of ideological and theological heritage of Abū Jafar Mu'min al-Ṭāq, and the second project is an analytical review of anthropology in the first five centuries of Islamic theology history.

2. The Anthropology of Imami Theologians in the first five centuries, Saeedeh Sadat Nabavi.



On November 30, 2017, coincided with the commemoration day of Shaykh Mufid, eight of the printed works in this macro-project were unveiled.



3. The Macro-project of “Reason and Religion”
 The explanation of the relationship between reason and religion has always been one of the most fundamental concerns for philosophers and theologians. Today, this problem is one of the most important issues in the philosophy of religion. Topics discussed in this domain are both theoretically and practically important and have a significant impact on the religious community. In order to consolidate religious principles in the theoretical domain, and strengthen religious rituals in the field of theology, the Theology Department is carrying out macro-project of “reason and religion”. In this macro-project, theologians and philosophers have been selected from those in both Islam and Christianity, and through comparing their ideas with each other, it is tried to explain the views of Muslim thinkers in this regard.

Department of Ethics

Our general understanding of morality reflects the rules guiding our behavior. But careful consideration of this human dimension leads to complex issues that account for a large amount of philosophical and theoretical research. Considering the importance of ethical issues in human life and the extent of the theoretical debates of this field in various aspects of normative ethics and metaethics, in particular the importance of applied ethics, the Research Center for Philosophy and Islamic Theology pursues scholarly research on this subject through the formation of the Department of Ethics Department and tries to enhance Islamic research in the field of ethics through dealing with common issues in ethics, defining the macro-research projects, forming academic groups, holding meetings and publishing research and reliable works. At present, the

macro-project of “theories of ethics” is active and in the near future the macro-project of “the morality of death and life” in the field of applied ethics and “epistemology of ethics” in the domain of metaethics will be carried out. 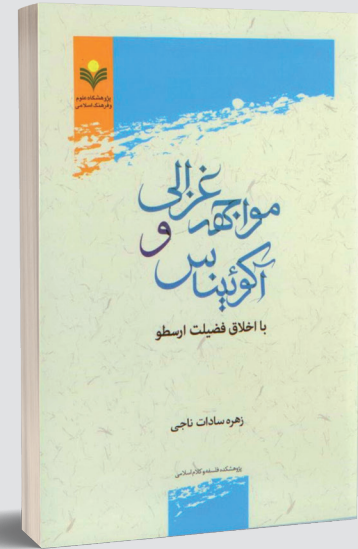
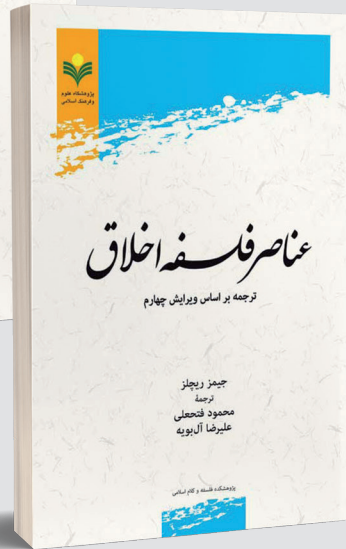
